

How does a board know when a district is "doing well?" What is the board's role?

- Have a vision/ENDS statement
- Clearly articulate measurable/actionable goals aligned with the vision
- Identify roles and responsibilities:
 - Policy
 - Funding
 - Other resource allocation
- What operational changes does the administration need to lead in order to see progress?
- Inventory all work in progress related to the goal
- Prioritize work for the year ahead
- Agree upon a schedule for monitoring each goal area throughout the year
